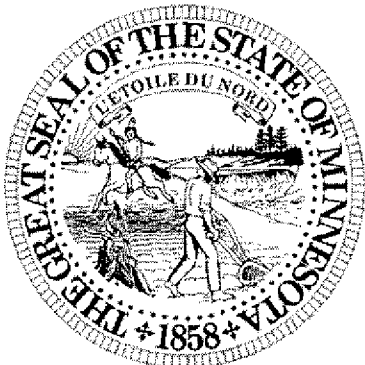

*Pursuant to Section 302A.687 of the Minnesota Business Corporation Act*

These Articles of Conversion are being submitted for filing with the Minnesota Secretary of State for the purpose of converting Kroll Ontrack Inc., a Minnesota corporation, into a Minnesota limited liability company under the name "Kroll Ontrack, LLC" pursuant to the Minnesota Business Corporation Act (the "Act") and the Minnesota Revised Uniform Limited Liability Company Act. The undersigned, being duly authorized to execute and file these Articles of Conversion, does hereby certify as follows:

1. The Plan of Conversion, in a form required by Section 302A.683 of the Act, is attached to these Articles of Conversion as Exhibit A (the "Plan of Conversion") and is hereby made a part of these Articles of Conversion.
2. The name of the converting organization immediately before the filing of these Articles of Conversion is Kroll Ontrack Inc. (the "Converting Entity").
3. Upon the effectiveness of these Articles of Conversion, the name of the Converting Entity will be changed to Kroll Ontrack, LLC (the "Converted Entity").
4. The Converted Entity will be a Minnesota limited liability company.
5. The Plan of Conversion has been approved by the Converting Entity in the manner required under Section 302A.685 of the Act.
6. These Articles of Conversion shall be effective upon filing with the Minnesota Secretary of State.
7. The Articles of Organization of the Converted Entity shall be those attached as Schedule I to the Plan of Conversion.

*Pursuant to Section 302A.683 of the Minnesota Business Corporation Act*

1. The name of the converting organization is Kroll Ontrack Inc. (the "Converting Entity").
2. The name of the converted organization is Kroll Ontrack, LLC (the "Converted Entity").
3. The Converted Entity is a Minnesota limited liability company.
4. Upon effectiveness of the conversion, all outstanding shares of the Converting Entity's capital stock shall convert into membership interests of the Converted Entity such that each share of stock shall convert into one unit of membership interest.
5. Upon effectiveness of the conversion, all directors of the Converting Entity shall cease to be directors of the Converting Entity, and the Converted Entity shall have no directors, governors or managers and shall be member-managed.
6. Upon effectiveness of the conversion, the initial officers of the Converted Entity shall be as specified in the limited liability company agreement of the Converted Entity.
7. A copy of the Articles of Organization of the Converted Entity is attached to this Plan of Conversion as Schedule I.
