Assignor further assigns to Assignee the right to sue and collect damages for any and all past, present and future infringement of any rights in the Trademarks and Related Rights. This Assignment is binding upon the parties and their respective heirs, successors, assigns, trustees, and representatives. Assignor agrees to execute any other documents or to provide any further materials or documentation necessary in order to fulfill the provisions or purpose of this Assignment. This Assignment shall be governed by and construed under the laws of the State of Indiana without giving effect to the choice of law principles thereof.
