DECLARATION UNDER TMEP §503.06(c)

Sir:

I, Robert E. Lewis, do hereby declare and state as follows:

1. I am Senior Vice President and General Counsel of Masonite International Corporation, I have the authority to make this Declaration on behalf of Masonite International Corporation, and I have firsthand knowledge of the facts stated herein. I hold a corresponding position with Masonite Corporation, which corporation is related to Masonite International Corporation.

2. On February 6, 2015, a document purporting to be an Assignment of the entire interest in each of the above-captioned United States trademark registrations was recorded in the U.S. Patent & Trademark Office ("PTO") at Reel/Frame 5454/0554.

3. The recorded document is dated February 4, 2015 and is between Marshfield Doorsystems, Inc. and Masonite International Corporation.

4. Prior to execution of that document, Marshfield Doorsystems, Inc. merged with and into Masonite Corporation on December 28, 2014, with the surviving company being named Masonite Corporation. A true and accurate copy of the Certificate of Merger issued by the State of Delaware is attached to my Declaration and, with my approval, has been or will be submitted for recordal in the PTO.

5. The true and correct current owner of the above-captioned U.S. registrations is Masonite Corporation.


6. All right, title, and interest in the above-referenced registrations was transferred into Masonite Corporation on December 28, 2014 by virtue of the Certificate of Merger between Masonite Corporation and Marshfield Doorsystems, Inc., and therefore the subsequent document recorded thereafter on February 4, 2015 at Reel/Frame 5454/0554 was improper, ineffective, or otherwise erroneous.

7. TMEP § 506.03(c) provides “[w]hen the owner of an application or registration discovers that another party has improperly recorded an assignment, name change, or other interest against the owner’s application or registration, the owner should initially contact the party who filed the improper recording and have that party record corrective documents. See TMEP §503.06(a) regarding typographical errors in the cover sheet. *If that party files corrective documents, the Assignment Recordation Branch will record the assignment, change of name, or other interest in the correct application or registration, and remove any references to the application or registration in which the improper recording was made.* The assignment, change of name, or other interest will remain at the reel and frame number where it was originally recorded, but a search of the assignment records will not associate the improper recording with the owner’s property.” (Emphasis added).

8. On behalf of Masonite International Corporation, I have authorized the filing of the Certificate of Merger and corrective documents, including this Declaration, to identify Masonite Corporation as the owner of all right, title, and interest in the above registrations.

9. Pursuant to TMEP § 506.03(c), I hereby requests recordation of Certificate of Merger and the corrective documents and removal of any reference to the registrations in which the improper recording was made.

10. The signatory being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or submission or any registration resulting therefrom, declares that all statements made of his/her own knowledge are true and all statements made on information and belief are believed to be true.

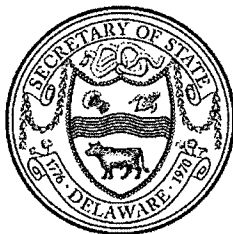


