GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS AND PATENTS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Lakana LLC, a Delaware limited liability company (the "Grantor") with principal offices at 545 E. John Carpenter Freeway, Suite 700, Irving, TX 75062, hereby assigns and grants to Bank of America, N.A., as Collateral Agent, having an office at 335 Madison Avenue, New York, NY 10017 (the "Secured Party"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all of the Grantor's right, title and interest in and to the United States patents (the "Patents") set forth on Schedule B attached hereto, in each case together with (iii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks and Patents, (iv) the goodwill of the businesses with which the Marks are associated and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same. Notwithstanding the foregoing, no security interest is granted or assigned in any trademark application filed on an intent-to-use basis until such time, if any, as a Statement of Use or Amendment to Allege Use has been filed and accepted in the United States Patent and Trademark Office.

THIS GRANT OF SECURITY INTEREST is made to secure the satisfactory performance and payment of all the Obligations, as such term is defined in the Security Agreement among the Grantor, the Secured Party and the other parties thereto, dated as of July 7, 2015 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Security Agreement"). Upon the occurrence of the Lien Termination Date (as defined in Section 10.10 of the Security Agreement), the Secured Party shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks and Patents acquired under this Grant of Security Interest.

This Grant of Security Interest has been executed and delivered in conjunction with the security interest granted to the Secured Party under the Security Agreement. The rights and remedies of the Secured Party with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interest are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


