**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Agreement") dated as of August 20, 2015, from Credit Suisse AG, Cayman Islands Branch, a banking corporation of Switzerland, as Collateral Agent for the benefit of Secured Parties (defined in the Security Agreement) ("Agent"), in favor of US LBM Holdings, LLC, a limited liability company of Wisconsin; BEP/Lyman, LLC, a limited liability company of Delaware; Desert Lumber – US LBM, LLC, a limited liability company of Delaware; Hines Building Supply – US LBM, LLC, a limited liability company of Wisconsin; Wisconsin Building Supply – US LBM, LLC, a limited liability company of Wisconsin (each, a "Grantor" and collectively, the "Grantors").

WITNESSETH:

WHEREAS, Grantors are a party to the Pledge and Security Agreement (Term Loan Facility) dated as of May 2, 2014 (the "Security Agreement") by and among Grantor and other grantors party thereto and the Collateral Agent pursuant to which Grantor was required to execute that certain Trademark Security Agreement, dated May 2, 2014 (the "Trademark Security Agreement");

WHEREAS, in connection with the Trademark Security Agreement, the Agent was granted a security interest in all of each Grantor's right, title and interest in, to and under all Trademark Collateral (as defined in the Trademark Security Agreement) from the Grantors (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the "USPTO") on July 18, 2014 at Reel 5325 and Frame 0775; and

WHEREAS, the Agent now wishes to release its liens on, and security interests in, the Trademark Collateral, including, without limitation, the Trademarks as set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

1. Release of Security Interest. The Agent hereby terminates, releases and discharges all of its security interest in the Trademark Collateral, and assigns and relinquishes any and all right, title and interest that it may have in or to the Trademarks to the Grantors.


2. Recordation. The Grantors or their authorized agents are authorized to record this Agreement with the USPTO.


3. Governing Law. This Agreement and the rights and obligations of the parties under this agreement shall be construed in accordance with and governed by the laws of the state of New York.

4. Further Assurances. The Agent shall take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by such Grantor, and at such Grantor's cost and expense, to more fully and effectively effectuate the release of liens and security interests contemplated hereby.

IN WITNESS WHEREOF, the undersigned has executed this Agreement by its duly authorized officer as of the date first above written.



