TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, effective as of the __12th__ day of __August__ 2015, by and between I.Q. ASSIGNOR hereby warrants and covenants that (i) it has the full power and authority to convey the rights, title, and interest herein assigned, transferred, and sold to ASSIGNEE; (ii) there are no judgments, decrees, orders, liens, encumbrances, restrictions, security interests, or agreements against or binding upon the Trademarks or ASSIGNOR which prohibits or restrict the use of the Trademarks; (iii) it has not executed and will not execute any agreement in conflict herewith; and (iv) that it will execute any and all other instruments which may be necessary to perfect and evidence ASSIGNEE's ownership of the property and rights herein conveyed.


The Parties agree that this Assignment constitutes the entire agreement between ASSIGNOR and ASSIGNEE with respect to the subject matter hereof. The Parties also agree that no modification or waiver or any amendment to any provision of this Assignment shall be binding upon either party unless it is made in writing and signed by both Parties.



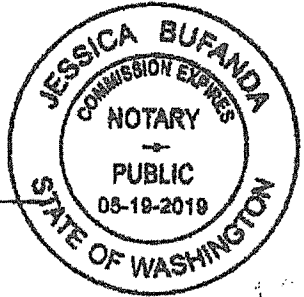
