**RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF
COLLATERAL**

July 31, 2015

Reference is hereby made to that certain Amended and Restated Intellectual Property Security Agreement, dated as of May 25, 2012 (the "*Agreement*"), executed by CS Operating, LLC, a Texas limited liability company ("*CS Operating*"), whose address is 1080 W Sam Houston Pkwy, Houston, TX 77043, Church Services Acquisition Company, a Delaware corporation (the "*Church Services*"), whose address is 1080 W Sam Houston Pkwy, Houston, TX 77043, and DFW Comfort Experts, Inc. ("*DFW Comfort*", and together with CS Operating and Church Services, collectively, "*Grantor*"), whose address is 1080 W Sam Houston Pkwy, Houston, TX 77043, in favor of Prosperity Bank, a Texas banking association, as successor to The F&M Bank & Trust Company ("*Secured Party*"), which was recorded in the United States Patent and Trademark Office on May 31, 2012, Reel 004791, Frame 0964, pursuant to which the Grantor assigned and granted to the Secured Party a security interest in and to all of the Grantor's right, title and interest in and to the IP Collateral (as defined in the Agreement), including, but not limited to, the trademarks and other intellectual property described in *Schedule 1* attached hereto (the IP Collateral, including such trademarks and other intellectual property described in *Schedule 1*, collectively, the "*Subject Collateral*");

WHEREAS, the Obligations (as defined in the Agreement) have been satisfied and Secured Party wishes to terminate the Agreement, release said security interest in and to the Subject Collateral, and retransfer and reassign to the Grantor, without representation or warranty, all of Secured Party's right, title and interest in and to the Subject Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby terminates the Agreement, releases said security interest in and to the Subject Collateral, and retransfers and reassigns to the Grantor, without representation or warranty, all of Secured Party's right, title and interest in and to the Subject Collateral.

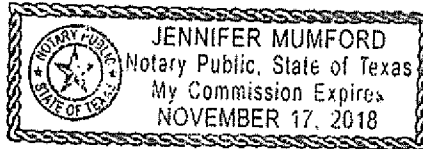
