## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of August 18, 2015 by **BANK OF AMERICA, N.A.**, as Collateral Agent (in such capacity, the "*Agent*"), in favor of each of **TUESDAY MORNING, INC., TUESDAY MORNING PARTNERS, LTD., TUESDAY MORNING CORPORATION, TMI HOLDINGS, INC., FRIDAY MORNING, INC., DAYS OF THE WEEK, INC.,** and **NIGHTS OF THE WEEK, INC.** (collectively, the "*Grantors*").

**WHEREAS**, the Grantors executed and delivered an Intellectual Property Security Agreement dated as of December 15, 2008 (the "*Original IP Agreement*"), granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein (collectively, the "*Original Marks*");

**WHEREAS**, pursuant to that certain First Amendment to Intellectual Property Security Agreement dated as of November 17, 2011 (the "*First Amendment*", and together with the Original IP Agreement, collectively, the "*IP Agreement*"), the Original IP Agreement was amended to add certain additional trademarks and trademark applications thereto (collectively, the "*Additional Marks*", and together with the Original Marks, collectively, the "*Marks*");

**WHEREAS**, the Original IP Agreement and the First Amendment were recorded in the Assignment Division of the United States Patent and Trademark Office on December 31, 2008, at Reel 3911, Frame 0582, and November 21, 2011, at Reel 4664, Frame 0369, respectively;

**WHEREAS**, the Grantors have requested that the Agent provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases and discharges its liens and security interests in the Marks identified on Schedule 1.
