SERVICE MARKS SECURITY AGREEMENT

This Service Marks Security Agreement (this "**Agreement**") is entered into as of August 21, 2015, by FLORIDA AUTISM CENTER, LLC ("**Debtor**"), a Florida limited liability company and successor to Florida Autism Center Inc., a Florida corporation, by conversion, in favor of TENTH STREET FUND III, L.P. ("**Lender**"), a Delaware limited partnership.

RECITALS:

A. Pursuant to that Loan Agreement (the "**Loan Agreement**") dated as of the date hereof by and among Debtor, Debtor's affiliate, and Lender, Lender has agreed to extend credit to Debtor, on certain terms and conditions (capitalized terms not otherwise defined herein have the meanings provided in the Loan Agreement).

B. Debtor has granted to Lender a security interest in all of its personal property and fixtures pursuant to that Security Agreement dated as of the date hereof among Debtor, Debtor's affiliate, and Lender (as it may be amended or restated, the "**Security Agreement**").

C. Debtor wishes to execute this Agreement to supplement the terms of the Security Agreement and to place of record Debtor's grant of a security interest to Lender in Debtor's service marks registered in the United States.

AGREEMENT:

NOW THEREFORE, as an inducement to cause Lender to extend credit to Debtor, and for other valuable consideration, the receipt and sufficiency of which are acknowledged, it is agreed as follows:

1. UCC Security Interest in Registered Service Marks. As security for the Obligations, Debtor hereby grants to Lender a security interest in the service mark applications described in Schedule A hereto and of record with the United States Patent and Trademark Office (the "**USPTO**") and in any service marks arising therefrom.

2. Recordation. Debtor hereby authorizes Lender to record this Agreement with the USPTO.

3. Other Agreements. This Agreement is executed to supplement and further evidence the security interest granted to Lender under the Security Agreement. The rights and remedies of Lender with respect to the security interest granted hereby are in addition to those set forth in the Loan Agreement, the Security Agreement, and the other Loan Documents, and those which are now or hereafter available to Lender as a matter of law or equity.

This Service Marks Security Agreement is dated as of the date first written above.
