TRADEMARK ASSIGNMENT

This Trademark Assignment effective as of ~~August 12, 2015~~ <sup>August 12, 2015</sup>, by Stranger & Stranger Limited, a corporation registered in England & Wales under Company Number 2932142 with a place of business at Unit 53 Kingsway Place Sans Walk London EC1R 9LU [formerly of 46A Carnaby Street London W1F 9PS] ("Assignor"), in favor of Luxco, Inc., a Missouri corporation with a place of business at place of business at 5050 Kemper Drive, St. Louis, Missouri 63139 ("Assignee"). Luxco and Stranger & Stranger are collectively referred to hereon as the "Parties."

WITNESSETH

WHEREAS, Assignor is, as between the Parties, the owner of all right, title and interest in and to the trademark OATH, in connection with alcoholic beverages except beers (the "Mark") and any and all goodwill associated with the Mark, and is the registered proprietor of United States Trademark Registration No. 4,043,715 (the "715 Registration");

WHEREAS, Assignee desires to acquire all rights to the Mark;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Parties, intending to be legally bound hereby, agree as follows:

1. Assignor hereby irrevocably assigns and transfers to the Assignee all its right, title and interest in and to the Mark that it currently holds and the 715 Registration, together with the goodwill associated with, attached to and/or symbolised by the trademark, including all rights to apply for and receive trademark registrations of the Mark, together with all rights of action accrued, accruing and to accrue under and by virtue hereof, including the rights to sue and to receive all damages, payments, costs, and fees associated therewith, but WITHOUT the goodwill in Stranger & Stranger's other business unrelated to the Mark.

2. Upon the reasonable request of the Assignee, the Assignor shall execute and deliver any and all instruments and documents and take such other actions as may be necessary or reasonably requested by Assignee to document the aforesaid assignment and transfer or to enable Assignee to secure, register, maintain, enforce and otherwise fully protect its rights in and to the Assigned Trademark.
