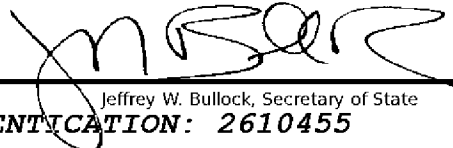

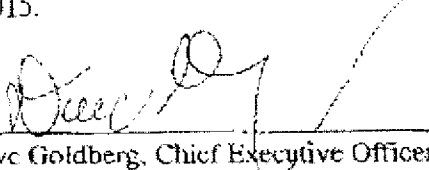
The name of the Corporation is Cadence Education, Inc.
