Recitals

- A The Assignor is the owner of the trade marks, designs and patent listed in Schedule 1 (the **Assigned IP**).
- B The Assignor now wishes to assign to the Assignee the whole of its present and future interest in the Assigned IP.

This deed witnesses as follows:

1 Assignment

Assignment of Assigned IP

The Assignor assigns to the Assignee (and the Assignee accepts the assignment of):

- (a) the Assignor's right, title and interest in and to the Assigned IP (exclusive of goodwill of the business); and

2 Performance

- (a) filing a change of name request with the relevant IP authorities to reflect the change of its name from VIP Petfoods Pty Ltd to Zanuinn Pty Ltd; and

- (b) filing a copy of this deed and an assignment request with the relevant IP authorities.

3 General

3.1 Governing Law and Jurisdiction

- (a) This document and the transactions contemplated by this document are governed by the laws of Queensland.
- (b) Each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of Queensland and any courts which have jurisdiction to hear appeals from any of those courts and waives any right to object to any proceedings being brought in those courts.

3.2 Invalidity

- (a) If a provision of this deed or a right or remedy of a party under this deed is invalid or unenforceable in a particular jurisdiction:
 - (i) it is read down or severed in that jurisdiction only to the extent of the invalidity or unenforceability; and
 - (ii) it does not affect the validity or enforceability of that provision in another jurisdiction or the remaining provisions in any jurisdiction.
- (b) This clause is not limited by any other provision of this deed in relation to severability, prohibition or enforceability.

3.3 Third party rights




