CORRECTION TO ASSET PURCHASE AGREEMENT

This CORRECTION TO ASSET PURCHASE AGREEMENT (the "Agreement") is made this _____ day of July, 2015 (the "Effective Date") to correct an error in the Asset Purchase Agreement (the "APA") made between Qliktag Software, Inc., a Delaware corporation, (the "Buyer"), and Klinette H. Kindred, as Chapter 7 Trustee for epcSolutions, Inc., (the "Seller"), on March 31.

The sixth bullet point listed under "Intellectual Property Assets" listed in Exhibit A- Purchased Assets of the APA incorrectly listed the Serial Number of another trademark already listed in the APA. The sixth bullet point shall now read as follows:
