DECLARATION

I, Nina Habib Borders, hereby state that the following details regarding the Assignment of Patents, Trademarks, Tradenames, Etc. as Security (the “**Security Agreement**”) made on September 15, 1984 by M.C. Canfield Sons, Inc., a New Jersey corporation, and The Namrevlis Development Company, a New Jersey partnership (collectively, the “**Assignor**”), and delivered to Mellon Bank (East) National Association (the “**Assignee**”) are accurate. The Security Agreement was recorded with the U.S. Patent and Trademark Office on September 21, 1984, under Reel/Frame No. 0476/0427. Of those trademarks included in the Security Agreement, only the registrations for COPPER-MATE (Reg. No. 902606) and BOW (Reg. No. 947920) are active.

The Security Agreement provides that Assignor and Assignee executed financing agreements and related documents providing certain loans and advances to Assignor by Assignee (the “**Financing Agreements**”).

The Security Agreement further provides that as security for Assignor’s liabilities and obligations to Assignee, Assignor granted to Assignee a continuing lien on and security interest in certain assets of Assignor associated with or related to products sold under Assignor’s trademarks, service marks and trade names under which Assignee is entitled to foreclose or otherwise deal with the assets, patents, trademarks, service marks and trade names (the “**Security Interest**”). Assignor assigned the Security Interest in certain trademarks to Assignee.

The Security Agreement provides that upon Assignor’s performance of all its obligations under the Financing Agreements and full satisfaction of all of Assignor’s liabilities and obligations to Assignee, Assignee shall execute and deliver to Assignor all documents necessary to re-vest in Assignor full title to the trademarks.

A release of the Security Interest in the trademarks has not been recorded by Assignee with the U.S. Patent and Trademark Office.

M. C. Canfield Sons, Inc. recorded a change of name to Canfield Technologies, Inc. with the U.S. Patent and Trademark Office on June 30, 2010, under Reel/Frame No. 4234/0457. The trademarks were then assigned to Kaydon Acquisition XI, Inc. The assignment was recorded on October 25, 2000, under Reel/Frame No. 2174/0398.

In order to perfect a security interest in trademarks or other general intangibles, the Uniform Commercial Code (the “**UCC**”) generally requires the filing of a financing statement with the Secretary of State in the jurisdiction in which the debtor is located. In general, under Section 9515 of the UCC, a financing statement is effective for a period of five years from the date of filing. The effectiveness of a filed financing statement lapses upon the expiration of such period unless a continuation statement is filed prior to such lapse in accordance with the UCC. Upon such lapse the security interest in question would, in general, become unperfected. Upon the timely filing of a continuation statement in accordance with the UCC, the effectiveness of the original financing statement is continued for five years after the last date on which the filing was effective, whereupon such filing would lapse in the same manner unless another continuation is

filed prior to such lapse. Succeeding continuation statements may be filed in the same way to continue the effectiveness of the financing statement.

There are no UCC financing statements (or continuation statements) filed of record during the last five years in Delaware (the jurisdiction of incorporation of Kaydon Acquisition XI, Inc.) or New Jersey (the jurisdiction of incorporation of M.C. Canfield Sons, Inc. and the jurisdiction of formation of The Namrevlis Development Company) for either of the original debtors or the subsequent assignee. Therefore, any financing statement related to the Security Interest that has not been affirmatively released is no longer perfected. The UCC records for Delaware and New Jersey are attached to this Declaration.

I respectfully request that the Security Interest granted to Assignee for the trademark registrations COPPER-MATE (Reg. No. 902606) and BOW (Reg. No. 947920) and recorded with the U.S. Patent and Trademark Office on September 21, 1984 under Reel/Frame No. 0476/0427 be released.

The undersigned being hereby warned that willful false statement and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements may jeopardize the validity of the application or document or any registration resulting therefrom, declares that all statements made of his/her own knowledge are true, and that all statements made on information and belief are believed to be true.



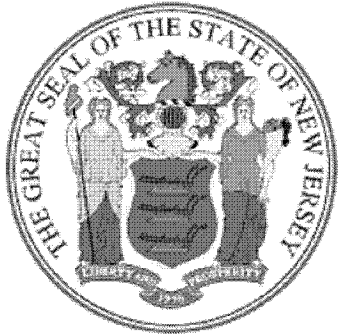

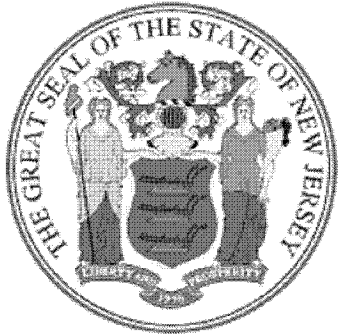
