WHEREAS, Assignee is desirous of acquiring said Trademarks and the registration and applications thereof together with the established goodwill therein;


WHEREAS, Assignor desires to convey, transfer, assign, deliver, and contribute to Assignee all of its rights, titles, and interests in and to the Trademarks;
