**TERMINATION AND RELEASE  
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS)** (“Release”), dated as of August 31, 2015, by **WEBSTER BANK, NATIONAL ASSOCIATION** (the “Lender”), in favor of **LDI OPERATIONS, LLC**, a Delaware limited liability company (the “Company”).

**WHEREAS**, pursuant to the terms of that certain Security Agreement, dated as of October 20, 2011 (the “Security Agreement”), and that certain Grant of Security Interest (Trademarks) (the “Agreement”), dated as of October 20, 2011, by and between the Company and the Lender, the Company granted to the Lender a security interest in and to all of the right, title and interest of the Company in and to the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the “Trademarks”), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (together with the Trademarks, the “Collateral”), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement);

**WHEREAS**, the Lender wishes to terminate and release its security interests in and to all of the right, title and interest of the Company in and to the Collateral, including the Trademarks identified on Schedule A attached hereto; and


**WHEREAS**, the Agreement was filed on October 28, 2011 with the United States Patent and Trademark Office in Reel: 004650; Frame: 0703.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Company in and to the Collateral, as granted under the Security Agreement and the Agreement, and reassigns and transfers to the Company all right, title and interest that the Lender may have in the Collateral, and terminates the Agreement. The Lender hereby authorizes the Company, or the Company’s authorized representative, to record this Release with the United States Patent and Trademark Office.
