NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS

NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of August 31, 2015 (this "Agreement"), among ALTEGRITY, LLC, a Delaware limited liability company ("Borrower"), CVM SOLUTIONS, LLC, an Illinois limited liability company ("CVM"), HIRERIGHT, LLC, a Delaware limited liability company ("HireRight"), KROLL ASSOCIATES, INC., a Delaware corporation ("Kroll Associates"), KROLL, LLC, a Delaware limited liability company ("Kroll"), KROLL ONTRACK, LLC, a Minnesota limited liability company ("Kroll Ontrack") NATIONAL DIAGNOSTICS, LLC, a North Carolina limited liability Company ("National Diagnostics") and, together with the Borrower, CVM, HireRight, Kroll Associates, Kroll and Kroll Ontrack, each a "Grantor" and collectively, the "Grantors") and CERBERUS BUSINESS FINANCE, LLC, as Collateral Agent (the "Collateral Agent") for the Secured Parties.

Reference is made to the Credit Agreement Guarantee and Collateral Agreement, dated as of August 31, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Altegrity Acquisition, LLC, a Delaware limited liability company ("Holdings"), the Borrower, the subsidiaries of the Borrower party thereto and the Collateral Agent. The Lenders have extended credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement. Consistent with the requirements of the Credit Agreement and pursuant to and in accordance with Section 3.01(c), Section 3.02(b) and Section 3.06(e) of the Security Agreement, the parties hereto agree as follows:

SECTION 1. **Terms.** Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement. The rules of construction specified in Section 1.02 of the Credit Agreement also apply to this Agreement.

SECTION 2. **Grant of Security Interest.** As security for the payment or performance, as the case may be, in full of the Obligations, each Grantor, pursuant to the Security Agreement, did and does assign, pledge and grant to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by such Grantor and wherever located or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral");

(a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I and Schedule II;

(b) all extensions or renewals of any of the foregoing;

(c) all goodwill associated therewith or symbolized thereby;

(d) all other assets, rights and interests that uniquely reflect or embody such goodwill;

(e) the right to sue or otherwise recover for any past, present and future infringement or other violation thereof; and

(f) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto.

SECTION 3. **Security Agreement.** Each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. **Purpose.** This Agreement has been executed and delivered by each Grantor for the purpose of recording the grant of security interest with the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the Security Agreement.

SECTION 5. **Counterpart.** This Agreement may be executed in counterparts and delivered by facsimile or otherwise electronically, each of which will be deemed an original, but all of which together constitute one and the same original.
