## **RELEASE OF SECURITY INTEREST (Trademarks)**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of August 31, 2015 by the Agent (as defined below) for certain financial institutions in favor of the Credit Parties (as defined below).





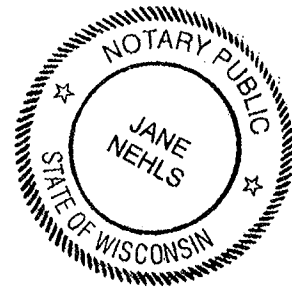
