RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of August 31, 2015 ("Effective Date") by and between Silicon Valley Bank, a California corporation ("Bank"), and The Network, Inc., a Georgia corporation ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Bank dated May 27, 2015 (the "Security Agreement"), Grantor granted to Bank a continuing security interest in and to all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under its Intellectual Property (as defined in the Security Agreement), including without limitation as set forth in Schedule A attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Bank.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby terminates the Security Agreement and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral.

Bank represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property Collateral; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark or service mark or any application or registration therefor, trade name, trade styles, logos, or trademark license, or any copyright, copyright registration, copyright application, or copyright license, other than those set forth on Schedule A (attached hereto), in any jurisdiction throughout the world (other than the filing of a UCC financing statement covering general intangibles generally).

Bank shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
