

GENERAL CONTRACT (ADULT SPORTS)

THIS GENERAL CONTRACT is entered into February 12, 1999 by and among PEOPLE TO PEOPLE INTERNATIONAL, a Missouri not-for-profit corporation qualified as a 501(c)(3) organization ("PTPI"), AMBASSADORS INTERNATIONAL, INC., a Delaware corporation ("Ambassadors") and AMBASSADOR PROGRAMS, INC., a Delaware corporation and a wholly-owned subsidiary of Ambassadors ("AP").

4. Ownership and License of Service Marks.

A. PTPI warrants and represents to AP that it is the owner of the service marks listed in Schedule A attached hereto (the "Marks"). PTPI represents and warrants that each of the Marks are registered with the United States Patent and Trademark Office. PTPI hereby grants to AP a non-exclusive license to use such Marks in promoting and conducting Adult Sports Programs in accordance with the terms of this Contract. 7. Quality Control. The parties recognize and agree that the value and public image of PTPI sanctioned projects/ delegations are enhanced by their high level of quality and acceptance by people and nations abroad and by the established non-profit and public service nature of PTPI and to that end it is appropriate for PTPI to exercise quality control over PTPI sanctioned exchange programs. AP agrees to permit PTPI to monitor and evaluate with its staff the conduct of any and all PTPI projects/delegations conducted under this Contract and to respond promptly and in detail to any inquiries of regarding the conduct of projects/delegations and to allow PTPI to review the correspondence files as related to participant complaints. In such instances, AP agrees to provide PTPI with an expeditious and detailed report. In addition, AP shall send PTPI information i.e. participant names, dates of trips, itinerary, etc., in a timely fashion, for review, comment and approval prior to departure of a delegation.
