

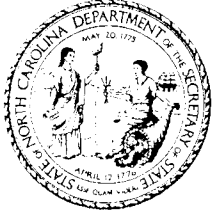

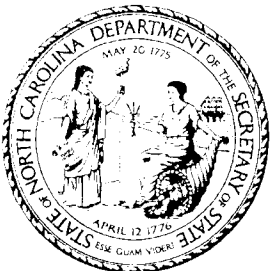

The name of the corporation is RegEd, Inc.


