RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of August 31, 2015 (the “Effective Date”), is made by Wilmington Trust (London) Limited, in its capacity as Security Agent (the “Security Agent”), in favor of the grantor party identified on the signature page hereto (the “Grantor”).

WHEREAS, pursuant to that certain Security Agreement, dated as of September 30, 2010, by and among the Security Agent, the Grantor and certain other parties thereto (as amended, amended and restated, supplemented, re-affirmed or otherwise modified through the date hereof, the “Security Agreement”), the Grantors granted to the Security Agent, in its capacity as Security Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Supplement to Security Agreement (Trademarks), dated as of September 30, 2010 (as amended, amended and restated, supplemented, re-affirmed or otherwise modified through the date hereof, the “Trademark Security Agreement”), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 13, 2010 at Reel/Frame 4295/0240;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Security Agent, without representation or warranty of any kind, hereby unconditionally and irrevocably releases, discharges, terminates and cancels all of its security interest in and to the Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademarks and trademarks applications set forth on Schedule 1 attached hereto, arising under the Security Agreement and the Trademark Security Agreement. If and to the extent that the Security Agent has acquired any right, title or interest in and to the Collateral (as defined in the Trademark Security Agreement) under the Trademark Security Agreement, the Security Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.


3. Termination. The Security Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.

4. Further Assurances. The Security Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the state of New York.
