FIRST: The name the corporation was incorporated was with the name Balance Studios, Inc. The name of the entity name upon renewal will be Balance Studio, Inc.

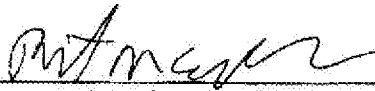
SECOND: The address of its registered agent in the State of Delaware is 1013 Centre Rd. Suite 403-A in the city of Wilmington, County of New Castle, 19805. The name of its registered agent at such address is American Incorporators Ltd.

THIRD: The date of filing of the Corporation's original Certificate of Incorporation in Delaware was January 09, 2009.

FOURTH: The date when the restoration, renewal, and revival of the charter of this company is to commence is February 28, 2011, same being prior to the date of the expiration of the charter. This renewal and revival of the charter of the corporation is to be perpetual.

FIFTH: This corporation was duly organized and carried on the business authorized by its charter until March 1, 2011 at which time its charter became inoperative and Voided for non-payment of taxes and this certificate for renewal and revival is filed by authority of the duly elected directors of the corporation in accordance with the laws of the State of Delaware.
