TERMINATION AND RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Second Lien Security Interest in Trademarks (the "Release") is executed as of August 31, 2015, by WILMINGTON TRUST COMPANY, as Collateral Agent for the several banks and other financial institutions (the "Lenders") under the Second Lien Credit Agreement referred to below (in such capacity, the "Collateral Agent"), in favor of Strategic HR Services, Inc. WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantor and the Collateral Agent executed a Trademark Security Agreement dated as of January 26, 2006 (the "<u>Trademark Security Agreement</u>") pursuant to which the Grantor granted to the Collateral Agent for the benefit of the Agent and the Lenders a continuing second lien security interest in, and a right of setoff against, all of the Grantor's right, title and interest in, to and under the Trademarks, including those items listed on <u>Exhibit A</u> hereto (the "<u>Security Interest</u>");

WHEREAS the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 27, 2006 at Reel 3254, Frame 0713; and

WHEREAS the Collateral Agent has agreed to terminate and release its Security Interest as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Collateral Agent hereby releases, terminates and discharges the Security Interest granted under the Trademark Security Agreement, and any right, title or interest of the Collateral Agent in such Security Interest shall hereby terminate, cease and become void. The Collateral Agent hereby consents to the recording of this Release with the United States Patent and Trademark Office and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
