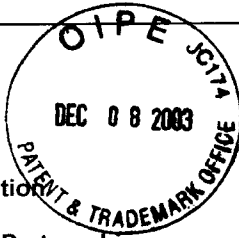

ASSIGNMENT OF TRADEMARK
