DOMAIN NAME AND TRADEMARK ASSIGNMENT AGREEMENT

This Domain Name and Trademark Assignment Agreement (this "Assignment") dated as of October 17, 2014 (the "Effective Date"), is made, executed and delivered by and between Dometic Sweden AB, a company duly organized and registered under the laws of Sweden ("Dometic Sweden"), and Atwood Mobile Products LLC, a Delaware limited liability company ("Atwood"). Dometic Sweden and Atwood are referred to in this Assignment each as a "Party" and collectively as the "Parties."

WHEREAS, Dometic Sweden is an affiliate of Dometic Corporation ("Buyer");

WHEREAS, Atwood is a wholly-owned subsidiary of Atwood Investment Holdings LLC (the "Company");

WHEREAS, the Company is a wholly-owned subsidiary of Atwood Holdings LLC ("Seller");

WHEREAS, Buyer, Seller and the Company are parties to that Purchase and Sale Agreement dated September 2, 2014 (the "Agreement"), pursuant to which Buyer has agreed to purchase all of the issued and outstanding limited liability company interests in the Company, effective as of the Effective Date.

WHEREAS, Section 6.9 of the Agreement provides that Buyer shall have the right to require the Company and Seller to take all commercially reasonable actions (including by causing the Company's Subsidiaries to take all such commercially reasonable actions) which would be necessary for Dometic Sweden to acquire, immediately prior to the consummation of the acquisition of the Company by Buyer from Seller under the Agreement, the Intellectual Property Assets (or any portion thereof) from Atwood;

WHEREAS, Dometic Sweden and Atwood have entered into a Bill of Sale (the "Bill of Sale"), effective as of the Effective Time (as such term is defined in the Bill of Sale) wherein Atwood conveyed, assigned and sold to Dometic Sweden certain intellectual property assets, including registered and common law trademarks and domain names; and

WHEREAS, under the terms of the Bill of Sale, the Parties agreed to enter into this Assignment to memorialize Dometic Sweden's acquisition of all of Atwood's right, title and interest in, to and under the registered and common law trademarks and domain names assigned pursuant to the Bill of Sale, as more fully identified in Exhibit A, attached hereto (the "Transferred Assets").

NOW, THEREFORE, in consideration of the execution of the Bill of Sale and the Agreement, the payment of the consideration stipulated in the Agreement, the mutual promises and covenants hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound thereby, the Parties agree as follows:

1. Definitions. All capitalized terms that are used but not defined herein shall have the meaning set forth in the Agreement.

2. Assignment of Transferred Assets. Subject to the terms and conditions of the Bill of Sale and the Agreement, Atwood, for good and valuable consideration, receipt of which is hereby acknowledged, does hereby assign and transfer unto Dometic Sweden, all of its right, title, and interest in, to or under the Transferred Assets, including any and all goodwill associated therewith, all registrations therefor, all common law rights therein, any and all trademark and/or service mark rights related thereto, all income, royalties, damages and payments with respect thereto earned or accrued following the Effective Time, any and all causes of action (either in law or in equity), as well as the right to enforce any rights and file any causes of action, including without limitation the right to recover damages, for any past, present, or future infringement, misappropriation dilution or other unauthorized use of the Transferred Assets.

3. No Modifications of the Agreement. Nothing contained in this Assignment shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge, or in any way affect the provisions of the Agreement, including the warranties, covenants, agreements, conditions and representations contained in the Agreement and, in general, any of the rights and remedies, and any of the obligations and indemnifications, of Buyer, Seller or the Company set forth in the Agreement.

4. Further Assurances. Dometic Sweden and Atwood hereby agree, at any time or from time to time, at the reasonable written request of the other, to execute, acknowledge and deliver such further instruments of sale, assignment, transfer, conveyance, delivery or assumption and to take such other actions as the other may reasonably request in order to more effectively consummate the transactions contemplated by this Assignment. Without limiting the foregoing, Atwood shall promptly effect the transfer of the registration of the domain name registrations that are Transferred Assets utilizing the official procedure established by the current registrar of each such domain name registration for transferring the registration of such domain name.


5. Governing Law. This Assignment shall be construed and interpreted according to the Laws of the State of Delaware, without regard to choice of Law and conflicts of Law rules thereof.

6. Execution. This Assignment may be executed in counterparts, each of which will be deemed to be an original and all of which, taken together, will constitute but one and the same agreement. Any signature hereupon delivered by facsimile or electronic mail shall be deemed for all purposes as constituting good and valid execution and delivery of this Assignment by the Parties.


