NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of December 20, 2013 Assignor hereby sells, assigns and transfers to Assignee its entire right, title, and interest in, to and under the Mark and the registrations therefor, together with the goodwill of the business connected with the use of and symbolized by the Mark. All rights and privileges, including the right to sue for and receive all damages from any past or future infringements of the Mark, will be held and enjoyed by the Assignee, its successors, assigns and other legal representatives.
