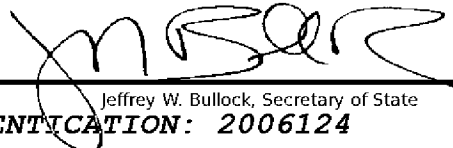

THIRD: The Company shall be the surviving limited liability company. The name of the surviving limited liability company is "Messenger, LLC".

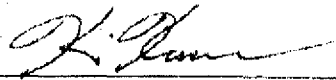
FOURTH: The merger shall become effective as of the date of filing of this Certificate of Merger with the Secretary of State of the State of Delaware.
