PATENT AND TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT dated as of March 31, 2015, by WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Secured Party").


