RELEASE AND REASSIGNMENT OF SECURITY INTEREST IN
TRADEMARKS AND TRADEMARK APPLICATIONS

Reference is hereby made to that certain Trademark Security Agreement, dated as of May 31, 2013 (the "Agreement"), executed by Dinan Corp., a Delaware corporation, ("Grantor"), whose address is c/o Dubin Clark & Company, 485 West Putnam Avenue, Greenwich, CT 06830, in favor of Zions First National Bank, National Association ("Agent"), which was recorded in the United States Patent and Trademark Office ("USPTO") on June 3, 2013 at Reel 005040, Frame 0123, pursuant to which the Grantor assigned and granted to the Agent a continuing security interest in and to all of the Grantor's right, title and interest in and to certain Trademark Collateral (as defined in the Agreement), including those trademarks and trademark applications specifically listed on Exhibit A attached hereto and the goodwill associated therewith;

WHEREAS, the Agent wishes to terminate, cancel, release, relinquish and discharge its security interest, and retransfer and reassign to the Grantor, without representation or warranty, all right, title and interest in and to the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, cancels, releases, relinquishes and discharges its security interest, and retransfers and reassigns to the Grantor, without representation or warranty, all right, title and interest in and to the Trademark Collateral and any goodwill associated therewith.

The Agent hereby agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as Grantor may reasonably request to effect the release of Agent's security interest as contemplated hereby, in each case at Grantor's expense.
