RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (“Release”) is made effective as of September 9, 2015 by ACF FINCO I LP, a Delaware limited partnership (the “Lender”) to SUN & SKIN CARE RESEARCH, LLC, a Delaware limited liability company (the “Grantor”), as follows:

WHEREAS, pursuant to the Patent and Trademark Security Agreement, dated as of June 12, 2014 (the “Trademark Security Agreement”), by and between the Grantor and FCC, LLC, d/b/a First Capital (the “Original Lender”), the Grantor irrevocably pledged and assigned to the Original Lender, and granted to the Original Lender a security interest with power of sale to the extent permitted by law in, all of the Grantor’s right, title and interest in and to (a) the trademarks, service marks, collective membership marks, registrations and applications for registration for each, and the respective goodwill associated with each, (b) the licenses, fees or royalties with respect to each, (c) the right to sue for past, present and future infringement, dilution and damages therefor and (d) licenses thereunder, including, without limitation, the marks listed on Schedule A hereto (collectively, the “Trademark Collateral”);

WHEREAS, pursuant to the Assignment and Assumption of Security Interests in Trademarks, dated as of May 18, 2015, by and between the Original Lender and the Lender, the Original Lender irrevocably assigned to the Lender, and the Lender assumed from the Original Lender, the Trademark Security Agreement and all rights, remedies, obligations and other interests of the Original Lender thereunder; and

WHEREAS, the Lender wishes to release and terminate its security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Trademark Security Agreement.
2. Release. The Lender hereby releases, discharges, terminates and cancels its security interest in the Trademark Collateral, including, without limitation, any and all right, title and interest it has in, to or under the Trademark Collateral under the Trademark Security Agreement.
3. Termination. The Lender hereby terminates and cancels the Trademark Security Agreement.
4. Further Assurances. The Lender hereby agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and

all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release.

5. Costs. Any reasonable costs incurred by Agent shall be borne by Grantor.







