ACTE DE CESSION DE LA MARQUE AMERICAINE ENREGISTREE

TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement"), effective as of April 30, 2010 is made by and between LUVANIS S.A., a Luxembourg *société anonyme* with offices at 4, rue Dicks, L-1417 Luxembourg, Luxembourg ("Assignor") and RENAISSANCE 1849, a Luxembourg *société anonyme* with offices at 11A boulevard du Prince Henri, L-1724 Luxembourg, Luxembourg ("Assignee")

WITNESETH

WHEREAS, Assignor purchased on November 16, 2009 from Tippin & Co who has adopted, used and registered in the United States Patent and Trademark office the trademark MOYNAT, Registration No. 3,430,511, in connection with the goods listed thereon (the "Mark");

WHEREAS, Assignor and Assignee have entered into a memorandum of understanding regarding the transfer of the intellectual property rights attached to the Moynat designation (the "Protocole d'Accord de Cession") dated as of the date hereof, pursuant to which Assignor agrees to assign all right, title, and interest in the Mark, both statutory and common law, as well as the goodwill associated with the Mark and the business symbolized thereby; and

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor represents and warrants that it has the full power and corporate authority to make the assignment documented herein and the signatory below has the full power and authority to act on behalf of the Assignor.
2. Assignor hereby assigns, transfers and conveys unto Assignee all of the Assignor's right, title and interest in and to the Mark, both statutory and common law, any other common law trademark used in connection with the sale of products by the Assignor, the goodwill of the business symbolized thereby.
3. Assignor makes no representations or warranties in connection with its rights in the Mark, it being understood that the Assignor is assigning any rights it may have therein "as is" and without warranty of any kind, and Assignee hereby accepts the disclaimer of any and all warranties and representations by the Assignor.
4. Assignor covenants that it will execute all documents, papers, forms, authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks.
