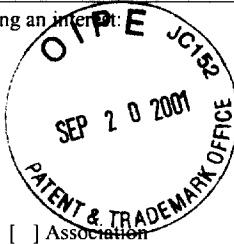

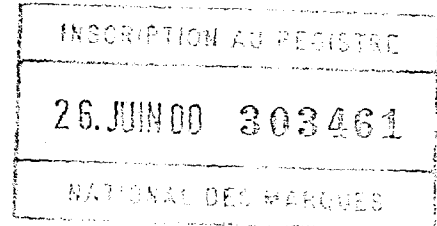

## Transfer of Intellectual Property Rights

- WHEREAS FIFA and ISL Properties AG entered into an agreement dated August 27, 1987 (hereinafter "Agreement 1") relating to the exploitation of the marketing rights of the FIFA World Cups 1990, 1994 and 1998 as further specified in such agreement;
- WHEREAS FIFA and ISL Properties AG entered into a separate agreement dated August 27, 1987 (hereinafter "Agreement 2"), granting to ISL the rights to use, to file and to register trademarks and copyrights of FIFA (hereinafter "1987 FIFA IP-Rights") in its own name but with the obligations to transfer any 1987 FIFA IP-Rights registered in the name of ISL to FIFA at the request of FIFA at the expiration of Agreement 2; the complete list of such 1987 FIFA IP-Rights is attached to this Agreement in Appendix 1;
- WHEREAS Agreement 1 and Agreement 2 have expired on 31 December 1998;
- WHEREAS ISL Marketing AG have entered into a new agreement with FIFA on December 12 1997 (hereinafter "FIFA Brand Licence Agreement") in which ISL Marketing AG's obligation to transfer any 1987 FIFA IP-Rights is set forth (as provided in Sections 3.1 to 3.5 of such agreement);
- WHEREAS the goodwill of the 1987 FIFA IP-Rights remained with FIFA at all times;
- WHEREAS A detailed list of the 1987 FIFA IP-Rights (specifying countries, application and registration references, classes of products and services) which have been registered in the name of ISL in accordance with the terms of Agreement 2 and which FIFA has requested the transfer to FIFA in accordance with the terms of Agreement 2 and of the FIFA Brand Licence Agreement is attached to this Agreement as Appendix 2;

NOW, THEREFORE, in accordance with the obligations contained in Agreement 2 and in the FIFA Brand Licence Agreement, the parties agree as follows:

## 1. TRANSFER

- 1.1 FIFA herewith requests the transfer of, and ISL herewith transfers to FIFA all and each of the 1987 FIFA IP-Rights listed in Appendices 1 and 2 in consideration of 1000 CHF paid by FIFA, the receipt of which is hereby acknowledged (hereinafter "Transfer").
- 1.2 This Transfer extends to all countries and to all classes or categories the 1987 FIFA IP-Rights extend to, whether registered or not.
- 1.3 ISL herewith fully, unconditionally and irrevocably consents to FIFA registering such Transfer with the competent authorities, trademark offices or courts.

- 1.4. Should certain specific applications / registrations be omitted from the list of the 1987 FIFA IP-Rights set forth in Appendix 2, ISL and FIFA undertake to execute without delay any appropriate document in order to proceed to the transfer of such specific 1987 FIFA IP-Rights in favour of FIFA.

## 2. EFFECTIVE DATE AND REGISTRATION

- 2.1 The Transfer shall be effective as of the date hereof and shall be valid regardless of whether such Transfer of a registered 1987 FIFA IP-Rights is registerable and regardless of whether FIFA registers such Transfer.
- 2.2 Where recordal must be deferred until pending trademark registrations are complete, ISL undertakes to maintain the prosecution of those applications at ISL's cost until they are registered.

## 3. TERRITORIAL LIMITATION OF TRANSFER

- 3.1 The Transfer shall not extend to any individual national 1987 FIFA IP-Right which would be invalidated by such Transfer, or the use of which would not be considered valid use enuring to FIFA where use of the 1987 FIFA IP-Right is necessary to keep the 1987 FIFA IP-Rights valid. It shall be FIFA's sole responsibility to determine such territorial limitations and to accordingly inform ISL.
- 3.2 In such case and upon written request of FIFA, ISL shall continue to hold the 1987 FIFA IP-Right on a fiduciary basis for and on behalf of FIFA, to the extent that this does not invalidate the 1987 FIFA IP-Right.

## 4. NON-TRANSFERABILITY OF SINGLE RIGHTS

Where 1987 FIFA IP-Rights are not transferable in full (such as but not limited to the rights deriving from "Urheberrecht"/"droit d'auteur") such transfer shall, for the territory of the countries in which such rule applies, extend to all individual rights transferable and assignable under the legislation in question.

## 5. SPECIAL TRANSFER DOCUMENTS

- 5.1 FIFA may at any time, at FIFA's cost, request recordal of this Transfer with the competent authorities, trademark offices or courts. ISL consents to such recordals and undertakes to issue, execute and deliver without delay any and all documents which may be necessary to FIFA for that purpose.
- 5.2 For the purpose of recordal, the parties agree to execute, in particular, the document attached to this Agreement as Appendix 3.
- 5.3 If any document signed for the purpose of recordal contains a limitation of transfer, the text of this Agreement shall prevail and no statement or stipulation in such a separate Transfer contract or other transfer document shall limit the scope of Transfer of 1987 FIFA IP-Rights as agreed in this Agreement.

## 6. REPRESENTATIONS

- 6.1 ISL hereby represents to FIFA, that all registrations of 1987 FIFA IP-Rights in the name of ISL or in the name of any company affiliated to ISL have been disclosed to FIFA in a true and correct manner. ISL further represents to FIFA that the list of the 1987 FIFA IP-Rights under Appendix 1 is complete, exhaustive and accurate at the date of signature of this Agreement. However, the detailed list of the 1987 FIFA IP-Rights under Appendix 2 may contain certain errors or have certain omissions. Such error or omission will be regularised without delay in accordance with Section 1.4 above.
- 6.2 FIFA hereby acknowledges that FIFA's representatives had a satisfactory access to all documentation relating to the 1987 FIFA IP-Rights and that ISL in executing this Agreement, and subject to the continued performance of ISL's obligations set forth in Sections 1.4 and 5.1 of this Agreement, has duly fulfilled all of its contractual obligations under Agreement 2 and under Sections 3.2.1 to 3.2.5 of the FIFA Brand Licence Agreement.
- 6.3 ISL hereby represents to FIFA that none of 1987 FIFA IP-Rights have been or are pledged in whole or in part, and any and all of the rights the subject of Appendix 1 are transferred to FIFA free and clear of any liens attributable to ISL.
- 6.4 ISL hereby represents to FIFA that at the date of this Agreement:
- a) ISL is entitled to, has the corporate power to and holds the power of a legal owner for the purpose of effecting the transfer hereunder.
  - b) The transferred 1987 FIFA IP-Rights are transferable to the extent permitted by each national jurisdiction.
  - c) No material litigation or arbitration are current against ISL in relation to the 1987 FIFA IP-Rights except as disclosed in writing to FIFA.
  - d) There are no shareholders' meetings outstanding in which resolutions are to be passed that could affect in any way whatsoever the transfer of the 1987 FIFA IP-Rights to FIFA.
- 6.5 ISL and FIFA hereby represent that this Agreement has been duly entered into and constitutes the legal, valid and binding obligations of the parties.

## 7. SEVERABILITY

- 7.1 If any provision of this Agreement is or becomes illegal, invalid or unenforceable in any jurisdiction, that shall not affect:
- a) the validity or enforceability in that jurisdiction of any other provision of this Agreement; or
  - b) the validity or enforceability in any other jurisdiction of that or any other provision of this Agreement.

7.2 In such case the parties will negotiate in good faith to replace the relevant provision by another provision reflecting as closely as possible the original intention and purpose of the parties.

#### 8. WAIVERS AND MODIFICATIONS

8.1 This Agreement and the rights of each party hereunder may be waived, amended or modified only specifically and in writing if signed by the parties hereto. Delay in exercise or non-exercise of any such right is not a waiver of that right.

8.2. This Agreement together with Agreement 1, Agreement 2 and the FIFA Brand Licence Agreement contains the whole agreement between the parties relating to the Transfer of the 1987 FIFA IP-Rights, with the exception of any other document which may be necessary as provided for in Sections 1.4 and 5.1 above.

#### 9. COUNTERPARTS

This Agreement may be executed in any number of counterparts and this has the same affect as if the signatures on the counterparts were on a single copy of this Agreement.

#### 10. LAW AND JURISDICTION

10.1. This Agreement shall be governed in all respects by and construed in accordance with the substantive laws of Switzerland.

10.2. Each party submits to the exclusive jurisdiction of the Commercial Court of the Canton of Zurich, Switzerland, venue being Zurich 1, with the right to appeal to the Swiss Federal Court in Lausanne as provided by law, whose judgment shall be final, for all purposes relating to this Agreement.

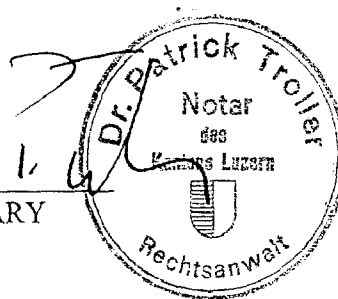

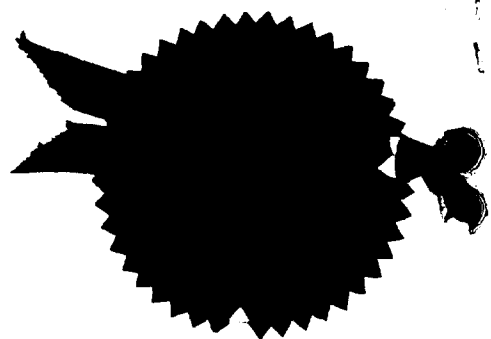
