RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) dated as of September 14, 2015 (“Effective Date”), from **JPMorgan Chase Bank, N.A.**, as Administrative Agent (together with its successors, in such capacity, the “Administrative Agent”) for the Secured Parties, to the entities listed on Schedule A hereto (collectively, the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the IP Security Agreement (in each case, as defined below), as applicable.

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement by and between the Grantors and the Administrative Agent dated October 21, 2010 (the “Security Agreement”), Grantors granted to the Administrative Agent a security interest in certain intellectual property;

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and among the Grantors and the Administrative Agent dated October 21, 2010 (the “IP Security Agreement”), Grantors, by reference to the Security Agreement, reaffirmed their intent to grant such security interest to the Administrative Agent specifically in certain Collateral (as that term is defined in the IP Security Agreement), including that set forth on Schedule B hereto;

WHEREAS, the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 22, 2010, at Reel 4304 and Frame 0050;

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, without representation, warranty or recourse of any kind, terminates, discharges, cancels and releases any and all security interests it has against the Collateral.

Administrative Agent shall take all further actions (including, the execution and delivery of any and all documents or other instruments), reasonably necessary to effect the release of the security interest contemplated hereby, and at Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the laws of the State of New York.
