RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE is made on this 10<sup>th</sup> day of August, 2015, by U.S. BANK, NATIONAL ASSOCIATION, as Administrative Agent ("Lender") having an office at 214 North Tryon Street, 26<sup>th</sup> Floor, Charlotte, North Carolina 28202.

WHEREAS, pursuant to that certain Term Loan and Security Agreement dated as of June 29, 2012 (as the same may be amended, modified, extended or restated from time to time, the "Security Agreement") by and among NEBRASKA BOOK COMPANY, INC., a Delaware corporation, formerly known as New Nebraska Book Company, Inc. ("Parent"), CAMPUS AUTHENTIC LLC, a Delaware limited liability company ("Campus Authentic"), COLLEGE BOOKSTORES OF AMERICA, INC., an Illinois corporation ("College Bookstores"), NBC TEXTBOOKS LLC, a Delaware limited liability company ("NBC Textbooks"), NET TEXTSTORE LLC, a Delaware limited liability company ("Net Textstore"), SPECIALTY BOOKS, INC., a Delaware corporation ("Specialty Books"; together with Parent, Campus Authentic, College Bookstores, NBC Textbooks, and Net Textstore, collectively, the "Grantors" and each, a "Grantor"), NEEBO, INC., a Delaware corporation ("Neebo"), NEEBO HOLDING COMPANY, a Delaware corporation ("Neebo Holding"; together with Neebo, the "Guarantors"), U.S. BANK NATIONAL ASSOCIATION, a national banking association, in its capacity as "Administrative Agent", and the "Lenders" from time to time party thereto, Grantors granted to Administrative Agent, for the benefit of the Lenders, continuing security interests (collectively, the "Security Interests") in and to certain intellectual property held by Grantors, including, without limitation, the trademarks listed on Schedule A (collectively, the "Trademarks"), pursuant to a Notice of Grant of Security Interest in U.S. Trademarks dated June 29, 2012, as filed with the United States Trademark and Patent Office at Trademark Reel 4829, Frame 0122 on July 25, 2012, and a Notice of Grant of Security Interest in U.S. Trademarks dated June 3, 2013, as filed with the United States Trademark and Patent Office at Trademark Reel 5040, Frame 0760 on June 4, 2013, and a Notice of Grant of Security Interest in U.S. Trademarks dated October 9, 2014, as filed with the United States Trademark and Patent Office at Trademark Reel 5378, Frame 0734 on October 9, 2014, and all of the goodwill of the business connected with the use of, and symbolized by, the Trademarks;


WHEREAS, the Security Interests are to be terminated and released in all such Trademarks as herein provided.
