TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 10, 2015, by **ANTARES CAPITAL LP**, successor by merger to GE Business Financial Services Inc., formerly known as Merrill Lynch Capital, a division of Merrill Lynch Business Financial Services Inc., as Administrative Agent ("**Agent**").

WITNESSETH:

WHEREAS, Agent and Martin-Logan, Ltd., a Kansas corporation ("**Grantor**"), were parties to that certain Trademark Security Agreement, dated as of October 31, 2005 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "**Trademarks**") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on November 4, 2005, at Reel 3188, Frame 0315; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "**Trademark Rights**"):

a. each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all the goodwill of the business connected with the use of , and symbolized by, each Trademark; and


b. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Rights.
