**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 10, 2015, by **ANTARES CAPITAL LP**, successor by merger to GE Business Financial Services Inc., as US Collateral Agent ("**Agent**").

WITNESSETH:

WHEREAS, Agent and Martin-Logan, Ltd., a Kansas corporation ("**Grantor**"), were parties to that certain Amended and Restated Trademark Security Agreement, dated as of August 30, 2010 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "**Trademarks**") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on August 30, 2010, at Reel 4269, Frame 0414; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

c. all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


