## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of September 15, 2015, is made by General Electric Capital Corporation, as administrative agent (in such capacity, together with its successors and permitted assigns, "Agent") in favor of Raising Cane's USA, L.L.C. ("Grantor"), as follows:

WHEREAS, pursuant to that certain Guaranty and Security Agreement, dated as of December 21, 2007, as amended and restated as of July 15, 2011, and as further amended and restated as of June 28, 2012 (the "Guaranty and Security Agreement"), Grantor executed and delivered to Agent (i) a Trademark Security Agreement executed as of December 21, 2007 (the "2007 TSA"), (ii) an Amended and Restated Trademark Security Agreement executed as of July 15, 2011 (the "2011 TSA"), and (iii) a Second Amended and Restated Trademark Security Agreement executed as of June 28, 2012 (the "2012 TSA" together with the 2007 TSA and the 2011 TSA each, a "Trademark Agreement" and collectively, the "Trademark Agreements");

WHEREAS, pursuant to the Guaranty and Security Agreement and each Trademark Agreement, Grantor, mortgaged, pledged and hypothecated to Agent, and granted to Agent a Lien on and security interest in and to all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Agreements), including without limitation the trademarks and service marks listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the "Marks");

WHEREAS, the 2007 TSA was recorded in the United States Patent and Trademark Office on December 28, 2017 at Reel 3686, Frame 0054;

WHEREAS, the 2011 TSA was recorded in the United States Patent and Trademark Office on July 19, 2011 at Reel 4586, Frame 0589;

WHEREAS, the 2012 TSA was recorded in the United States Patent and Trademark Office on June 29, 2012 at Reel 4812, Frame 0131; and


WHEREAS, Agent has agreed to terminate and release, without representation or warranty, all of Agent's right, title and interest in and to the Trademark Collateral, including without limitation the Marks and the goodwill associated therewith.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates and releases, without representation or warranty, its Lien on and security interest in, to and under the Trademark Collateral, and hereby re-assigns and re-transfers to Grantor, all of Agent's right, title and interest in and to the Trademark Collateral, including without limitation the Marks and the goodwill associated therewith.
