NOW, THEREFORE, for the foregoing recited consideration and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, as beneficial owners, do hereby assign, sell and transfer to Assignee all of their right, title and interest in and to the Marks and the Registration, together with the goodwill of the business symbolized by the Marks, the right to sue for past infringement thereof and all the benefits of the Marks and the Registration. Assignor further consents to the recordation of this assignment by Assignee with the United States Patent and Trademark Office.


