**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST**

WHEREAS, McCrane, Inc., a California corporation ("McCrane"), as borrower, and Comerica Bank ("Comerica"), as lender, are or were parties to a certain Amended and Restated Loan and Security Agreement, as may have been amended, restated, supplemented or otherwise modified from time to time, dated August 31, 2009 (the "Loan Agreement");

WHEREAS, all capitalized terms used but not otherwise defined herein shall have the meanings assigned to them in the Loan Agreement and the IP Security Agreement (as defined below);

WHEREAS, pursuant to the Loan Agreement and that certain Intellectual Property Security Agreement, dated as of August 31, 2009 (the "IP Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4075, Frame 0618 and Reel 23337, Frame 802, both on October 8, 2009, McCrane granted to Comerica a security interest in and to all of McCrane's right, title and interest in and to the Intellectual Property Collateral (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C thereto and hereto);


WHEREAS, Comerica acknowledges and agrees that all of McCrane's obligations with respect to the Loan Agreement and the IP Security Agreement have now been fully and completely satisfied and that the security interest granted has been and hereby is terminated; and

WHEREAS, Comerica desires to fully, completely and formally release its security interest in and to the Intellectual Property Collateral and in and to any and all other intellectual property of McCrane, and to record such release with the U.S. Patent and Trademark Office;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Comerica does hereby fully, completely and formally re-assign, release, relinquish and discharge its continuing security interest and any other interest it may have in the Intellectual Property Collateral and in any and all other intellectual property of McCrane.

IN WITNESS WHEREOF, the parties have caused this Release of Intellectual Property Security Interest to be duly executed as of September 15, 2015.
