**PARTIAL RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS PARTIAL RELEASE AND REASSIGNMENT OF TRADEMARKS (this "Release") is made as of August 31, 2015, by ANTARES CAPITAL LP (as successor via assignment to General Electric Capital Corporation), in its capacity as administrative agent ("Administrative Agent").

**WITNESSETH:**

WHEREAS, Administrative Agent and Thumbprint Ltd., an Ohio limited liability company ("Grantor"), were parties to that certain Trademark Security Agreement dated as of November 5, 2014 (the "Trademark Security Agreement"; capitalized terms used but not otherwise defined herein shall have the meanings ascribed thereto in the Trademark Security Agreement), which was recorded with the United States Patent and Trademark Office at Reel 5406, Frame 0153, and pursuant to which Grantor granted a security interest to Administrative Agent in, among other things, all of Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Exhibit A hereto; and

To the extent, if any, that following the release as set forth in Section 1 above Administrative Agent retains or would retain any right, title or interest in or to the Specified Trademark Collateral or any goodwill of any business conducted in connection therewith, Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest in, to and under the Specified Trademark Collateral, and the goodwill of Grantor's business connected with the use of and symbolized by the Specified Trademark Collateral.
