Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform other acts the Assignee may reasonably require in order to vest all Assignor’s right, title and interest in and to the Trademarks in the Assignee and/or to provide evidence to support any of the foregoing, to the extent such evidence is in the possession or control of the Assignor.
