**TRADEMARK AGREEMENT (USA)**

THIS AGREEMENT, effective from 1 January, 2015, is by and between BLUECREST CAPITAL MANAGEMENT LP, a limited partnership of Guernsey (“Assignor”) having an address at Redwood House, St Julian’s Avenue, St. Peter Port, Guernsey, GY1 1WA, and SYSTEMATICA INVESTMENTS LP, a limited partnership of Guernsey (“Assignee”) having an address at Redwood House, St Julian’s Avenue, St. Peter Port, Guernsey, GY1 1WA.

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark applications and registrations set forth on Schedule I hereto (hereinafter referred to collectively as the “Trademark Rights”); and

WHEREAS, Assignee is the successor to that portion of Assignor’s business to which the Trademark Rights pertain; and

WHEREAS, Assignee desires to acquire said Trademark Rights together with all of the goodwill of the business symbolized by the Trademark Rights; and

WHEREAS, Assignor is willing to assign, transfer, convey and deliver said Trademark Rights to Assignee on the terms and conditions set forth herein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby, absolutely and unconditionally, assign, transfer, convey and deliver unto Assignee, all of Assignor’s right, title and interest in and to the Trademark Rights, together with the goodwill of the business symbolized by the Trademark Rights.


Assignee shall not assign, transfer, mortgage, charge, subcontract, declare a trust over or deal in any other manner with the Trademark Rights without the prior written consent of the Assignor.

IN WITNESS WHEREOF, Assignor and Assignee have caused this Agreement to be executed by their duly authorized officers on this 12 day of AUGUST, 2015.
