TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is made as of September 17, 2015, by **GOLUB CAPITAL LLC**, a Delaware limited liability company, as successor administrative agent to Golub Capital Incorporated (in such capacity, the "Grantee"), in favor of **VINTAGE PARTS, INC.**, a Delaware corporation (the "Grantor").

W I T N E S S E T H:

WHEREAS, Grantor executed in favor of Grantee that certain Trademark Security Agreement dated as of December 21, 2007 (the "Agreement"; capitalized terms which are not defined herein have the meaning given to such terms in the Agreement);

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 8, 2008 at Reel 003692, Frame 0149 and on January 8, 2008 at Reel 003692, Frame 0156 and an Assignment of and Amendment to Trademark Security Interest dated January 31, 2014 was recorded on February 12, 2014 at Reel 004215, Frame 0783 and on January 31, 2014 at Reel 005214, Frame 0797;

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, Grantee has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee, on behalf of itself and the Lenders, hereby releases, terminates and cancels its security interest in and lien on all of Grantor's right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademark registrations and Trademark applications referred to in **Schedule 1** annexed hereto, and Grantee hereby terminates the Agreement.


2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest (if any) in and to the Trademark Collateral.

3. This Trademark Release and Reassignment is made under and governed by the laws of the State of New York applicable to contracts made and to be performed entirely within such State, without regard to conflict of laws principles.
