## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of this 18th day of September 2015, by NORTHSTAR MEZZANINE PARTNERS V L.P., a Delaware limited partnership ("Secured Party"), in favor of HUSKIE TOOLS, INC., an Illinois corporation ("Company").

WHEREAS, Company and Secured Party are parties to a certain Security Agreement, dated as of December 19, 2011 (the "Security Agreement"), pursuant to which Company granted to Secured Party a security interest in all or substantially all of the assets of the Company, including all right, title and interest of the Company in, to all of the Company's Trademarks and Trademark Licenses (each defined in the Security Agreement), and proceeds thereof;

WHEREAS, pursuant to the Security Agreement, the Company and Secured Party entered into a Trademark Security Agreement dated December 19, 2011 (the "Trademark Security Agreement"), pursuant to which the Company granted a continuing security interest in all of its right, title, and interest in, to an under the following: (i) each Trademark of the Company (together with any renewals, continuations or extensions thereof), including without limitation the Trademarks referred to in Schedule 1 of this Release; (ii) each Trademark License of the Company including without limitation the Trademark Licenses referred to in Schedule 1 of this Release, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark License; and (iii) all products or proceeds of the foregoing, including, without limitation, any claim by the Company against third parties for past, present or future (a) infringement or dilution of any Trademark, including without limitation, the Trademark registrations referred to in Schedule 1, the Trademark registrations issued with respect to the Trademark applications referred in Schedule 1, and the Trademarks licensed under the Trademark License, or (b) injury to the goodwill associated with any Trademark or Trademark licensed under any Trademark License (collectively, the "Trademark Collateral.");

WHEREAS, the Company recorded the Trademark Security Agreement with the United States Patent and Trademark Office on December 19, 2011 at Reel 4682 Frame 0264; and

WHEREAS, the Company has completed its Secured Obligations (as defined in the Security Agreement) under the Security Agreement and related agreements, and as such, Secured Party now wishes to acknowledge the termination of the Trademark Security Agreement and release all security interests it may have in, under, or to the Trademark Collateral.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged:

1. Release. Secured Party acknowledges that the Secured Obligations (as defined in the Security Agreement) have been paid in full, and the Trademark Security Agreement is hereby terminated. Secured Party hereby unconditionally and expressly releases, terminates, extinguishes, and waives, its liens, the security interest granted in the

Trademark Security Agreement, and any other interest it may have in the Trademark Collateral.


