NOW, THEREFORE, in consideration of the agreements made by Assignee under the Agreement and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer unto Assignee Assignor's entire and undivided right, title and interest in and to the Trademark, together with all the associated goodwill of its business symbolized thereby and all registrations of same, as well as all rights to injunctive relief, damages or profits, due or accrued, arising out of all causes of action, past, present, and future, including infringement of the Trademark, or other violations, or injury to the said goodwill, and the right to sue for and recover the same in Assignee's own name and the names of Assignee's successors, assigns or other legal representatives.

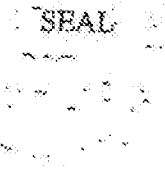
