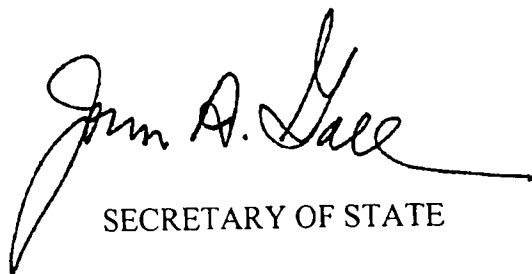

**ARTICLES OF ORGANIZATION OF
A-FAB, LLC**

**ARTICLE 1
NAME**

The name of this limited liability company is A-Fab, LLC (the "Company").

**ARTICLE 2
PURPOSE AND POWERS**

2.1 Purpose. The purpose for which the Company is organized is the transaction of any or all lawful business for which limited liability companies may be organized under the Nebraska Limited Liability Company Act, NEB. REV. STAT. §§ 21-2601 *et seq.* (the "Act").

2.2 Powers. The Company shall have and exercise all powers and rights conferred upon a limited liability company by the Act, and any enlargement of such powers conferred by subsequent legislative acts; and, in addition thereto, the Company shall have and exercise all powers and rights as are necessary, suitable, proper, convenient or expedient for the attainment of the purposes set forth in Section 2.1 above.

**ARTICLE 3
PRINCIPAL PLACE OF BUSINESS**

The Company's principal place of business in Nebraska is 340 Victory Lane, Lincoln, Nebraska 68528.

**ARTICLE 4
REGISTERED OFFICE AND REGISTERED AGENT**

4.1 Office. The registered office of the Company is 340 Victory Lane, P.O. Box 81906, Lincoln, Nebraska 68501.

4.2 Agent. The name of the registered agent of the Company at such address is Joyce Smith.

**ARTICLE 5
STATED CAPITAL**

The total amount of cash contributed to stated capital is \$1,000.00.

**ARTICLE 6
ADDITIONAL CAPITAL CONTRIBUTIONS**

Any additional capital contributions to be made by the Members and the times at which or events upon the happening of which such additional capital contributions shall be made shall be as provided in the Operating Agreement of the Company.

**ARTICLE 7
ADMISSION OF ADDITIONAL MEMBERS**

Additional Members shall be admitted to the Company, from time to time, upon such terms and conditions of admission as may be determined by the Members at the time of admission. Except as provided in the Operating Agreement, the interests of Members may not be transferred or assigned.

**ARTICLE 8
MANAGEMENT OF THE COMPANY**

The overall management of the Company shall be vested in one or more Managers which may be but are not required to be Members. The names and addresses of the initial Managers are as follows:
