AMENDMENT TO PIEL BROS., LTD.
LIMITED PARTNERSHIP AGREEMENT

This agreement is made and entered into this 4th day of August, 2008 by and between CHARLES W. BIDWILL, JR., Trustee of the Charles W. Bidwill Jr. Living Trust U/T/A dated 3/15/93, GENE IGNATOW, THOMAS P. HAWKES, Trustee of the Thomas P. Hawkes Trust U/T/A dated 3/10/89, ROBERT MOBERLY, DOROTHY R. MOBERLY, and ROGER K. METZ, being all the owners of all the outstanding Partnership Units of PIEL BROS., LTD., a limited partnership created by an Agreement of Limited partnership dated October 30, 1985 under the Illinois Limited Partnership Act.

The partners hereby reaffirm, readopt, and reconstitute the Limited Partnership Agreement dated October 30, 1985 in its entirety as from time to time heretofore amended, subject to the following amendments.

Pursuant to Article XXI of the Limited Partnership Agreement of PIEL BROS. LTD., the undersigned partners hereby amend said Limited Partnership Agreement as follows:


1. By revoking Article VI of said Limited Partnership Agreement in its entirety and by replacing it, effective December 1, 2005, with the following:

“The term of the Partnership shall continue to December 31, 2015, unless sooner terminated as hereinafter provided.”

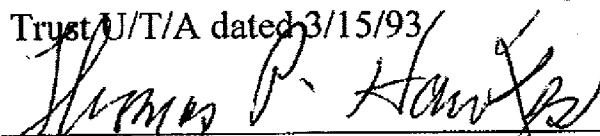
2. By revoking Article II of said Limited Partnership Agreement in its entirety and by replacing it with the following:

“The business of the partnership shall be conducted under the name of PIEL BROS. L.P. or such other name as the general Partner shall hereafter designate in writing to the Limited Partners.”

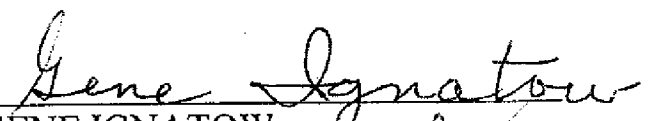

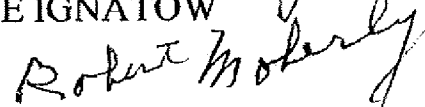
