TRADEMARK ASSIGNMENT

This assignment is made effective as of June 30, 2015.

In exchange for the consideration set forth in the Settlement Agreement dated June 30, 2015, among LA Gem & Jewelry Design, Inc. d/b/a LA Rocks ("LA Gem"), Gold Star Jewellery PVT Ltd. ("GS India"), Goldstar Jewellery LLC, Goldstar Independent LLC, and Fusionist, LLC ("Fusionist"), executed concurrently herewith (the "Settlement Agreement"), and in the Loving Arms License (as defined in the Settlement Agreement), LA Gem hereby assigns to GS India the following rights:

- (1) All rights and interests it may own or hold under the Trademark Assignment Agreement dated as of June 17, 2014, a copy of which is appended hereto, pursuant to which Fusionist assigned LA Gem Fusionist's LOVING ARMS Mark (as defined in the Settlement Agreement), except that the contractual license of Fusionist's LOVING ARMS Mark back to Fusionist shall terminate and Fusionist shall immediately cease using Fusionist's LOVING ARMS Mark.
- (2) LA Gem's trademark Application No. 86316403 for registration of the mark LOVING ARMS for use on jewelry ("LA Gem's Loving Arms Application").
- (3) Any and all rights and privileges provided under Fusionist's LOVING ARMS Mark and LA Gem's Loving Arms Application ("Marks"), any and all registrations of the Marks, and any and all renewals thereof, together with the right to bring suit and collect for past infringements thereof.
- (4) Any and all rights and privileges under the laws of unfair competition and other laws of the United States, the individual states thereof and jurisdictions foreign thereto with respect to the Marks.
- (5) The business GOODWILL associated with the Marks, with the exception of any and all goodwill associated with LA Gem's ARMS OF LOVE Mark (as defined in the Settlement Agreement), which shall remain the sole and exclusive property of LA Gem.

Nothing herein shall in any way abrogate, limit, or restrict Licensee's rights to ownership or use of the mark ARMS OF LOVE, as such rights are expressly preserved and set forth in the Settlement Agreement executed concurrently herewith.

LA Gem represents and warrants that it is the sole owner of all of the foregoing assigned rights and interests in Fusionist's LOVING ARMS Mark, and has not assigned or otherwise conveyed or encumbered any ownership interest, or right of use, in Fusionist's LOVING ARMS Mark or LA Gem's Loving Arms Application.

Further, in exchange for the consideration and mutual releases set forth in the Settlement Agreement, Fusionist hereby acknowledges, and agrees to, the immediate termination of its license to use Fusionist's LOVING ARMS Mark, and shall (1) immediately cease using Fusionist's LOVING ARMS Mark, and (2) hereafter not use in any manner Fusionist's LOVING ARMS Mark or GS India's LOVING ARMS Mark (as defined in the Settlement Agreement).

This Trademark Assignment is executed concurrently with, and is conditioned upon, the full execution of the Settlement Agreement and the Loving Arms License.


