**NOTICE OF SECURITY INTEREST**

WHEREAS, Ropack Inc., a corporation existing under the *Canada Business Corporations Act* with address of 10801 Mirabeau, Montreal, Quebec H1J 1T7 (the "Company"), together with certain affiliates, entered into a Credit Agreement dated on or about September 23, 2015 with National Bank of Canada, as Administrative Agent for the benefit of Secured Parties, with its designated office located 600 de la Gauchetière Street West, Ground Floor, Montreal, Quebec H3B 4L2 (the "Agent"), and, in connection therewith, executed a Deed of Hypothec on September 15, 2015 (the "Security Agreement"), in favor of Agent; and

WHEREAS, pursuant to the Security Agreement, the Company granted a security interest in Trademark Rights (the "Security Interest"), and pledged and granted to the Agent for the benefit of the Agent and the Secured Parties a security interest in its Intellectual Property, including the trademarks set forth on Schedule A (the "Trademarks").

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Company hereby provides notice of the pledge and grant to Agent of the Security Interest in and to the Trademarks. The security interest in the Trademarks is not to be construed as an assignment of any trademark or trademark application.
